RULES AND INFORMATION for National Blueberry Festival Pageant



All contestants must be at least 6 years old and not more than 12 years old by August 9, 2018. Contestants must continually reside with a parent or legal guardian and maintain a permanent residence within South Haven, Bangor, Covert, Grand Junction, Breedsville, Lacota, or Glenn.

The contestant represents that as of August 9, 2018, no other local, state, or national title shall be held. All entry fees are non-refundable and must be received no later than August 1, 2018.

The purpose of the National Blueberry Festival Pageant is to select representatives for the National Blueberry Festival. The National Blueberry Festival Pageant is a "natural" children's pageant. For this setting and all events in the year to follow, contestants are expected to wear little to no make-up and modest, age appropriate outfits. The National Blueberry Festival Pageant aims to provide local youth between the ages of 6 years old and 12 years old the opportunity to participate in local festivals and holiday celebrations, to gain social skills, and to learn more about the community of South Haven and the industry that South Haven is known for.

The court members will be chosen by judges that will remain anonymous until the start of the pageant and are chosen at the discretion of The National Blueberry Festival Pageant chairperson, Brianne Hooper. The judges will evaluate, with equal value, the three categories of interview personality, on-stage presentation, and on-stage question. Children ages 6 years old to 8 years old by August 9, 2018 will compete for the "Little Miss Blueberry Princess" or "Little Mister Blueberry Prince". Children ages 9 years old to 12 years old by August 9, 2018 will compete for the "Little Miss Blueberry" or "Little Mister Blueberry". If your child has previously served as the title holder for Little Miss, Little Mister, Princess, or Prince your child is not eligible to participate in the pageant event again at that age category. Titleholders who have served as court members or runners up are eligible to participate in the pageant more than one year, however, repeat participants are not granted any sort of preference over participants running for their first time.

The Court of Honor for 2018 is set to be: Little Miss Blueberry Princess, Little Miss Blueberry Princess First Runner Up, Little Mister Blueberry Prince, Little Mister Blueberry Prince First Runner Up, Little Miss Blueberry, Little Miss Blueberry First Runner Up, Little Mister Blueberry, and Little Mister Blueberry First Runner Up. Pageant participation is on a first-come-first-serve basis and is limited to the first ten applications received per category. **All pageant participants are welcomed and encouraged to participate in the National Blueberry Festival Parade on August 11, 2018 at 11:00AM.** The court make up and positions may be altered or added by The National Blueberry Festival Pageant chairperson, Brianne Hooper, supported by the Festival Committee, at any time without prior warning to contestants. No monetary compensation will be given to any members of the Court of Honor.
